Production method:

Made of cow milk, in the form of water in oil emulsion.

Cream got from milk whizzing is pasteurized, after physical ripening is continually buttered

Composition:

Pasteurized cream

Target market:

The general public – home public , export

Consumer application:

For straight consumption or for freezing and for further processing - ice-cream, cheese production etc.

Packaging:

Formalized butter – aluminium foil 100, 125 and 250 g

Block butter – 10kg, 25kg for further processing

Latest date of consumption / best before date:

Formalized butter – 60 days from the production date

Frozen butter – 14 days after defrosting

Shelf life:

Frozen butter – maximum -18°C

Fresh butter – temperature from +2°C to +8°C

Sensory specification:

Appearance and colour – natural, yellowish, with the shade of cream colour

Consistence – well spreadable, tiny water drops on the slice

Odour and flavour – almond-nut

Physical and chemical specification:
